Minutes of the Regular Meeting of the Township Committee of the Township of Commercial held on December 17, 2015 at 6:00 P.M., at the Township Hall, 1768 Main Street, Port Norris, NJ

Mayor Moore presided and called the meeting to order with the announcement that the meeting had been advertised, that it was being electronically recorded and being held in full compliance of the Open Public Meeting Act.

Mayor Moore asked everyone to stand and join him in the Flag Salute and Lord's Prayer.

Mayor Moore said we have Lt. Horsey here this evening and we'll call on him for his report.

Lt. Horsey said for the month of November they had 4 burglaries, 2 thefts, 7 motor vehicle accidents, 219 motor vehicle stops, 176 property checks. He said regarding the property checks that most residents don't realize that they have been there but they are out there checking mostly in the evenings. He still recommends that residents lock all their doors and windows, keep their garages, sheds, workshops locked up and if they have anything in their yards that can be used for scraps, put in their garages because otherwise it will be stolen.

Mayor Moore said we have the minutes or previous meetings for the committee's consideration:

Committeeman Sutton made motion to approve, Committeeman Jamison seconded with a unanimous roll call vote.

Mayor Moore asked for engineer's report and Mr. Dennis said he did not have any more to add. He was disappointed we did not get the Laurel Lake Drainage Grant Phase III but said we will submit it again. He said all of our grants have been completed and are being closed out at this time. He said we do have a resolution on the agenda for tonight awarding contract to Cambria Solar Ezngery for our solar project on municipal properties.

Committeeman Sutton said he had asked Ed to give him a cost estimate for decorative light in Haleyville and he said probably 20 lights at a cost of \$125,000.

Mr. Dennis said they would have to prepare bid specs for those lights.

Mayor Moore said at this point in time, we have no idea where this money would even come from and I've spoken to someone in Haleyville about it already and they said you're going to spend money on decorative lights. He said we have people coming from the area to get food from the food pantry.

Committeeman Sutton said we probably could get it done at \$100,000 and I want to put it on the agenda.

Mayor Moore said I'm not going to vote for it now, I'm not against it, but I feel we need to talk about it and plan it out, I told you if you found a grant to buy them I would be for it. I talked to Mike Vizzard and he said the cost would be \$6,000 per light and that would be more than what Mauricetown's cost. He said Mauricetown has 22 lights, Port Norris has 39 and there is 77 is Laurel Lake. Mayor said this is not a priority thing, it for decoration, that's all it is., there are people having their properties foreclosed on, in food lines each week, we have roads that need to be done, I'm against it at this point in time, but I would support it if we could talk about it and find out exactly what it will cost.

Committeeman Sutton said but you can find money for other things.

Mayor Moore said yes for necessary things, this is not necessary. I will be glad to look it over.

Mayor asked for solicitor's report and Mr. Seeley said he feels we should have several land sales during the course of the year, with smaller number of properties, and that tax office have properties that they are proposing for land sale have full inspections so we don't run into problems such as we did this year. He did say that the properties that were turned back over to us were not our fault, the county health department said properties would need new septic and wells, purchasers didn't feel they could afford it, they forfeited their ten percent deposits. Mr. Seeley said regarding the issue of Block 135, Lot 7011 purchased at landsale that has retention basin on it with a pipe that drains the water away, he has spoken to purchaser George Hiles and Kari Elmer and they want to keep the property, they do not want to sell it back to the township. Mr. Seeley said he suggest that township have engineer do an onsite inspection, find the location of the pipe see how important this drain is to the township and whether or not we can afford to let purchaser retain property.

Committee authorized engineer to do onsite inspection and see whether we need to take the property back. A motion was made and seconded to that effect, all in favor, aye.

Mr. Dennis said there are two steps, survey the lot and find out where the pipe is and then we would have to create an easement plan. He said the first step will cost to send a crew out there and survey about \$1500, to draw up and easement plan, \$1500, round number \$3,000.

Mayor said okay we have estimate from engineer, \$3,000 what's your estimation Tom.

Mr. Seeley said it depends on what type of paperwork, how many deeds are going to have to be prepared, I won't know until we decide what is going to be needed to finalize the matter.

Mayor said okay we approved for Ed to survey and give us a report on his findings and then if feasible, do an easement.

Mayor said they had been given a copy of the bill list for the month of December for consideration and could he have a motion.

Committeeman Jamison made motion to approve, Committeeman Sutton seconded, roll call vote unanimous.

Mayor Moore said I suggest we take Item VI Off of the agenda at this time until we have further discussions with the state regarding the TSR for state police barracks.

Mayor Moore said we received notification from state DEP that January is Radon Action Month and they suggest that all residents test their homes for radon which is leading cause of lung cancer.

Mayor said we received notice from DCA that our application for Laurel Lake Drainage Phase III was denied. Mayor said engineer had already told us this bad news.

Mayor said township had received a bid from Edward Jamison, of Millville in the amount of \$15,000 for Block 10, Lots 5243 thru 5254, 240X100, known as 3200 Lakeshore Drive, Millville, NJ This property was previously advertised pursuant to New Jersey Statutes in the local newspaper under Resolution 2015-92 as "Surplus Property". Mayor Moore turned the meeting over to Solicitor Seeley.

Mr. Seeley stated township has a bid of \$15,000 for Block 20, Lot 5243 thru 5254, 240X100, 3200 Lakeshore Drive. Is there anyone here this evening want to bid on this property, being none, I strike the bid three time, and ask the pleasure of the committee, do they want to sell. Mayor Moore made motion to sell, Committeeman Sutton seconded and the following roll call vote was taken:
