Mayor Vizzard called meeting to order with the announcement that the meeting had been advertised, it was being electronically recorded and held in full compliance of the Open Public Meeting Act.

Mayor Vizzard asked everyone to stand and join the committee in the Flag Salute and Lord's Prayer.

Mayor Vizzard said we have Lt. Horsey, of the New Jersey State Police present this evening and asked him for his monthly report.

Lt. Horsey said we had a busy month with the following statistics just from Commercial Township: 243 Service calls, 232 motor vehicle stops, 46 home inspections, 4 accidents, 3 drunk driving, and 9 thefts throughout of anything that is metal, laptops, cell phones, yard decorations, anything that can be salvaged or sold. He said everyone should keep their garages, sheds, homes, cars, boats, windows and doors locked. Stop leaving items on the seats of their cars.

Lt. Horsey said he would like to tell the committee of the tremendous amount of support the state police got on the fisherman that was lost somewhere out on the water. He said the marine police had assistance from fire companies, firemen were out in their boats, US Coast Guard, fishermen, oystermen, crabbers, and private citizens all out their looking to find the individual alive but as it turned out it was a recovery. He said he had never seen anything like it and the State Police was very thankful for all of the assistance they received.

Mayor Vizzard asked the audience if they had any questions and being none thanked Lt. Horsey and said the committee's thoughts and prayers are with the family.

Mayor Vizzard said we have previous meetings minutes for consideration:

ORDINANCE 2019-597

AN ORDINANCE OF THE TOWNSHIP OF COMMERCIAL GOVERNING THE MAINTENANCE OF VACANT PROPERTY, ESTABLISHING REQUIREMENTS, LEVYING A REGISTRATION FEE ON OWNERS OF VACANT PROPERTIES

Mayor Vizzard asked for motion to open meeting to the public and Committeeman Broughton made that motion and mayor seconded and asked if there were any comments from the public and being none the mayor asked for motion to close the public portion and to adopt the ordinance.

Committeeman Brought made motion to close public portion and to adopt the ordinance. Mayor Vizzard seconded the motion and roll call vote was unanimous of the committee members present.

Mayor Vizzard said we have resolutions and many of the resolutions on the agenda are in response to correspondence that was received and reviewed at the agenda meeting on the 16th.

RESOLUTION 2019-89

Authorizing The Award Of A Non-Fair And Open Contract For Replacement Of Computer Server And Upgrade Of Software and Perpherals

WHEREAS, the Township of Commercial has a need to acquire a new computer server and associated software as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and

WHEREAS, the anticipated term of this contract is one (1) year; and

WHEREAS, Computers & Networks Unlimited has submitted a proposal on August 23, 2019 indicating they will provide the computer server and associated software for \$22,583.20; and

WHEREAS, Computers & Networks Unlimited has completed and submitted a Business Entity Disclosure Certification which certifies that Computers & Networks Unlimited has not made any reportable contributions to a political or candidate committee in the Township of Commercial to Warren Vizzard, Fletcher Jamison, or Ryan Broughton in the previous one year, and that the contract will prohibit Computers and Networks Unlimited from making any reportable contributions through the term of the contract; and

WHEREAS, there are sufficient funds available in the 2019 Municipal Budget to fund this project – N.J.A.C. 5:30-5.4.

NOW, THEREFORE, BE IT RESOLVED that the Committee of Commercial Township authorizes the Chief Financial Officer to enter into a contract with Computers & Networks Unlimited as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.

Resolution In Support Of The New Jersey State League Of Municipalities'
Petition Rulemaking To Amend The Uniform Construction Code

WHEREAS, the State of New Jersey has adopted a Uniform Construction Code ("CUCC") with the purpose to provide for uniform construction standards to insure healthy, safe and sanitary construction, but also less expensive construction for citizens of the State; and

WHEREAS, the Department of Community Affairs ("DCA") has been granted authority to amend or alter provisions of the UCC to insure the intent and purposes of the UCC continue to be fulfilled; and

WHEREAS, municipal construction officials act as the enforcing agency tasked with administering and enforcing all provisions of UCC for Construction within Municipal Boundaries; and

WHEREAS, permits and inspections from the foundation for the safe building environment; and

WHEREAS, the DCA made amendments to N.J.A.C. 5:23-1.4, 2.7 & 2.17A commonly referred to as the "Minor Work" and "Ordinary Maintenance" provisions of the UCC that took effect on March 5, 2018, which undermine the UCC's intent and purpose; and

WHEREAS, unless these amendments are retracted or further remedial amendments are made to the UCC, the health, safety and welfare of the citizens of the State will be jeopardized and residents could see overall construction expenses increase if work is not properly performed; and

WHEREAS, THE New Jersey League of Municipalities along with New Jersey's six Professional Code Official Associations has filed a petition for rulemaking with the DCA requesting necessary and appropriate amendments be made to ensure the intent and purpose of the UCC is reinforced and preserved.

NOW, THEREFORE, BE IT RESOLVED, that Commercial Township supports the rulemaking petition submitted by the League and the six Professional Code Official Associations and requests that the DCA work to expeditiously adopt the measures offered by the petition; and

BE IT FURTHER RESOLVED, that copies of this Resolution be forwarded to the Governor and Lieutenant Governor of New Jersey, the Commissioner of the New Jersey Department of Community Affairs, Division of Codes and Standards and the New Jersey State League of Municipalities.

Approval To Remove Erroneous Improvement Value

WHEREAS, N.J.S.A. 54:4-9-91.1 requires the Tax Collector to report any property taxes she believes are uncollectible; and

WHEREAS, the Tax Assessor reported an erroneous assessment was placed upon property known as Block 212, Lot 9, assessed to Michael Blount, in the amount of \$40,600 (\$28,400 land an \$12,200 improvement) for the tax year 2019; and

WHEREAS, the Tax Assessor has indicated that a demolition of the improvement on this parcel was properly conducted in 2018 and the improvement value of \$12,200 should have been removed from the assessment and MODIV for 2019; and

Authorizing Remington & Vernick Engineers Perform Additional Work for the Reconstruction Whittier Dr., Iris Rd., and Magnolia Dr. NJDOT Grant, In Amount of \$13,000

Mayor Vizzard asked for a motion on the resolutions and Committeeman Broughton made motion to approve Resolution 2019-89 thru 2019-99. Mayor Vizzard seconded the motion and a unanimous roll call vote was taken of the committee members present.

Mayor Vizzard asked Committeeman Broughton if he had any reports and being none the Mayor said regarding the situation with Dagastine's Friendly Service at the corner of Main and Market Streets, Port Norris which code enforcement officer has brought to our attention with photographs that show it is in deplorable condition, the roof has fallen in, interior has rotted, it is dangerous and should be demolished.

Mayor Vizzard said the committee agrees with the code enforcement officer but at present we do not have money in the budget to do so. I strongly recommend that money raised for vacant property registration be used for cleaning up properties that have fallen in the laps of the municipality. Mayor said Ordinance 2019-597 was adopted this evening we can and will use those registration fees to tear down and clean up Dagastine's and other properties.

Mayor Vizzard asked Solicitor Seeley to look into why the Siera Club is against wastewater management in Downe Township.

Mayor Vizzard made motion to open meeting to the public.

Committeeman Broughton seconded the motion.

A Mr. Rodriguez asked if the Animal Control Officers contract was up.

Mayor Vizzard said it is not up until December 31, 2019, but we are going to advertise for 2020 within the next month. He asked Mr. Rodriguez if he was a certified animal control officer.

Mr. Rodriguez said no, he is not.

Mr. William Johnson, Parsons Lane, Port Norris, said people that own property on Sockwell Lane are bringing in Buffalo and he is concerned with the odor that the residents might have to deal with.

Committeeman Broughton and Mayor Vizzard questioned Mr. Johnson, did he know for fact that there are buffalo, has there been any odors supporting that there are buffalo on the property. Mayor said property is zoned for it.

Mr. Johnson said he didn't know if Buffalo is there yet, no he hasn't smelled any odor but that he expects there will be when they bring them in. Mr. Johnson said he is also concerned with the house across the street on North Avenue across from Parson's, these people moved in the property is a mess and township needs to do something about it.

Committeeman Broughton said Steve, Code Enforcement Officer, is aware and violation notices have been sent but the public has to realize that there are time limits that have to be followed, notices are sent then violations notices, then, it is taken to court, he the Code Enforcement Officer must follow the regulations.

Mr. Johnson said he is tired of having water come from North Avenue into his yard. He said he has complained numerous times.

Mayor Vizzard said North Avenue is a county road, you should contact them and bring it to their attention. If no one does anything, go to the Freeholders meetings, they have meetings just like we do and tell them about it. Call the county, I believe they meet on Tuesday, call them and tell the Freeholders about it.

Mr. Johnson said he has contacted the county and they have done nothing.

Mayor said then you need to tell it to the Freeholders.

Mr. Larry Heath, Milbourne Drive, Port Norris, asked why is Red Fern Drive more important than Milbourn Drive to get paved. He believes that Milbourne should be considered, also they need more street lights on Milbourne.

Mayor Vizzard said Red Fern has needed reconstruction for a long time, there are many homes, residents and motor vehicle traffic on Red Fern, it needs to be considered and we've applied for a grant to do it. I will have engineer to check out Milbourne and the street lights. If some of the lights are not working, get the pole numbers off of the poles that are not coming on at night and call the electric company and they will come out and repair them. The electric company does accept calls from residents and will respond.

Mrs. Huduka, Lakeshore Drive, Laurel Lake, said that she wanted to bring other abandoned properties to the committee's attention where doors are off, windows open and people going in and out.

Committeeman Broughton said he is sure that Steve is aware and that notices have been sent to the owners of property, it takes time to get to court.

Mayor Vizzard said he's sure it is being taken care of and he sees improvements in Laurel Lake and many residents from Laurel Lake said they have seen it also.

Mayor Vizzard asked for additional comments and being none asked for a motion to close the public portion and to adjourn the meeting.

Committeeman Broughton made motions and meeting was adjourned.
