

# 2020 Commercial Township Convenience Center PERMITS REQUIRED!

The Convenience Center is open to residents of Commercial Township only. Residents can obtain a permit to use the Convenience Center at the Commercial Township Municipal Building.

### **Are you eligible for a permit?**

Only residents of Commercial Township are eligible for permits. There is a limit of two permits per household. Residential property owners who do not live in Commercial Township must have their tenants obtain a permit. If there are no tenants, please arrange for a private entity to provide for trash pickup. Businesses are required to recycle and have trash removed from their facility. Commercial vehicles are not eligible for permits. **THERE ARE NO EXCEPTIONS TO THESE RULES.**

### **How to get your Convenience Center Permit**

Permits are required. Pick up your permit at the Commercial Township Municipal Building, Monday thru Friday 8:00am-4:00pm. New permits can also be obtained through the mail by written request *with a copy of your current driver's license, vehicle registration and self-addressed, stamped envelope.*

### **PROOF OF RESIDENCY AND VEHICLE REGISTRATION FOR VEHICLE THAT WILL BE USED FOR TRANSPORTING TRASH WILL NEED TO BE PRESENTED AT TIME OF ISSUING PERMIT!!!**

- Permits issued in 2020 will be in the form of a rear-view mirror hanging tag that will be registered to the license plate number of the vehicle used to transport your trash.
- The tag will need to be placed on your rear view mirror while on the Convenience Center property.
- Your permit will have your license plate number displayed on it and it **MUST** match the plate of the vehicle you are in.
- Permit will be valid for one (1) year and will need to be renewed each January.
- Limit of two permits per household.
- Initial Permit at no cost. Replacements or lost permits will cost \$5.00

### Tire permits

Special permits are required for the disposal of tires and can be obtained at the Commercial Township Municipal Building.

Small tires: \$3.00 each

Large truck or tractor tires: \$6.00 each

- *Attendants at the convenience center cannot issue permits or take payments*

### Additional Rules & Regulations

- ✓ ALL TRASH & DEBRIS MUST BE SEPERATED BY METAL, PLASTIC, and ELECTRONICS ETC. TO KEEP THE LINE MOVING
- ✓ NO MORE THAN TWO (2) TRUCK LOADS PER CLEAN UP DAY
- ✓ NO TRAILERS LONGER THAN 12' FOOT LONG
- ✓ TARPS ARE REQUIRED ON ALL VEHICLES
- ✓ NO LANDLORD CLEANOUTS

### What types of materials are not permitted?

Only small amounts of construction debris will be accepted. Please obtain a dumpster if you are performing renovations or large projects. Commercial Township Convenience Center does not accept curbside recyclables, cardboard, newspaper, bottles or glass. Propane tanks, fuel of any kind. NO boats, NO asbestos. Remove doors from all appliances before dropping off. Also, no vehicle batteries, chemicals, oil based paints, or solvents are accepted. They are disposed of through the Cumberland County Improvement Authority Household Waste Days.

### Acceptable Items

Household items, metal, washer & dryer, furniture, bicycles, yard furniture, plastic toys & playground items, lumber, mattresses

Electronics are accepted but must go in proper location. All electronics must be recycled including computers, TV's, monitors, stereos, radios, VCR's, etc.

**Brush, Leaves & Mulch;** are accepted on dump day from 9 am-1pm. If leaves are bagged, you will be required to remove leaves from bags and discard them in proper location.

Oil and Anti-Freeze can be brought to the Public Works Dept. on Tuesday & Thursday. Call Public Works prior to bringing material at (856) 785-3100 Ext. 331
