Mayor Vizzard presided and called the meeting to order with the announcement that the meeting had been advertised, that it was being electronically recorded and being held in full compliance of the Open Public Meeting Act.

Mayor Vizzard said we have no officials present so we'll go into the consideration of the minutes.

Committeeman Broughton made motion to approve and Committeeman Jamison seconded the motion with a unanimous roll call vote.

Mayor Vizzard said CFO, Pam Humphries, has provided committee with Bill List for the month of November 2019, is there a motion.

Committeeman Jamison made motion to approve and Committeeman Broughton seconded with a unanimous roll call vote.

Mayor Vizzard requested engineer's report.

Mr. Edward Dennis, Engineer, said he had submitted a Phase II application for Port Norris Riverfront Roadway Improvements in the amount of \$769,752.50, there hasn't been any update as of yet. Mr. Dennis said a NJDOT grant application was filed under Municipal Aid for Red Fern Drive as priority one, and Keron Drive as priority two. No updates. Mr. Dennis said Whittier Drive, Iris Road & Magnolia Drive Project was awarded to Arawak Paving Company and in amount of \$209,600, change order approved to extend work on Whittier.

Mr. Dennis said Remington & Vernick Engineers have submitted a proposal of \$162,000 for the Port Norris Riverfront Roadway Improvements and that they are prepared to start as soon as authorized. Mr. Dennis said approximately \$22,000 will come from municipal budget balance of funding comes from the grant. He asked that a resolution be approved.

Mayor Vizzard said Resolution 2019-108 to be added to the agenda to approve design phase.

Mayor Vizzard said we received three bids for the Animal Control Services. County Wide Animal Control was \$19,200, Animal Control of South Jersey was 12,000, and Shore Animal Control was \$14,400.

Mayor Vizzard proposed awarding the contract to Shore Animal Control because there is more staff and they have a person specifically designated for cruelty. A three-year contract with no increase was proposed.

Committeeman Broughton suggested a one-year contract.

Clerk said you wouldn't be able to lock in the cost.

The committee agreed to the three-year contract.

Committeeman Broughton made a motion and Committeeman Jamison seconded. Roll call.

Mayor Vizzard said next is Correspondence. We have a memo from John Nardone of the Environmental Commission requesting the Committee authorize advertisement additional members. They have five and are allowed seven.

Received 2020 contract from South Jersey Regional Animal Shelter for services provided to the animals that are picked up, trapped by the township's animal control officer. The cost for 2020 is \$24,835.00 paid monthly at \$2,069.59. There is an increase part reason being, last year's contract was for 10 months, this year it is based on 12 months. They say part of increase is due to mandatory wage increase costs.

Mayor Vizzard asked the clerk to send a letter to SJRAS expressing dissatisfaction of the increase.

Heather Whitaker has notified the clerk that she is lacking three alternatives on the Land Use Board. She would like to know if the committee knows anyone that would be interested in serving on the board to let her know.

Letter from Sharon Porter, Commercial Township PTA, requesting donation for their "Saturday with Santa" for the children who attend Commercial Township Public Schools.

The Committee agreed to donate \$500.00 as they have done in the past.
